VISION AND MISSION OF THE INSTITUTION:





CODE OF CONDUCT FOR THE HEAD OF THE INSTITUTION:


- ❖ The head of the institution should be committed to the overall development of the institution.

DISCIPLINE AND CONDUCT OF NON TEASING EMPLOYEES:


- All members of the staff should devote themselves to the fulfillment of the vision and mission of the institution.

DISCIPLINE AND CONTACT OF STUDENTS:
