- Propose and collaborate jointly in research or training programmes sponsored by UGC, NAAC and other funding agencies and invite each other faculty and students for special lecture for participation and exchange of knowledge etc.

"2nd institute will provide teachers and students including:

- Exchange of students and teachers for classes, projects-works, library facility etc. for better knowledge sharing and innovation and exposure.
- Exchange of information on research and educational programmes and involvement in research projects with collaboration.
- Organize seminar, webinars, conferences, workshops, symposiums etc. jointly on relevant topics relating to Education, Environment Awareness, etc.

General Terms and Conditions

- Duration of MOU:** This MOU will be effective from the above mentioned date and will have a duration of 02 (Two) years which may be extended with the consent of concerned authorities of both the intuitions.
- Engagement of department level coordinator:** The colleges will empower an appropriate faculty to co-ordinate the implementation of activities.
- Confidentiality:** Both the colleges will maintain strict confidentiality about the terms and conditions of this MOU.


