"1st" institute will provide teachers and students for the exchange of:

(i) Information on teaching learning materials and other educational collaboration including research programmes.

- (ii) Introduce short term courses and value aided courses with joint ventures.
- Promote cultural and intellectual enrichment opportunities for the students and (iii) faculties of both the institutions.
- Propose and collaborate jointly in research or training programmes sponsored by UGC, NAAC and other funding agencies and invite each other faculty and students for special lecture for participation and exchange of knowledge etc.

"2nd institute will provide teachers and students including:

- Exchange of students and teachers for classes, projects-works, library facility etc. for (i) better knowledge sharing and innovation and exposure.
- Exchange of information on research and educational programmes and involvement (ii) in research projects with collaboration.
- (iii) Organize seminar, webinars, conferences, workshops, symposiums etc. jointly on relevant topics relating to Education, Environment Awareness, etc.

General Terms and Conditions

- 1. Duration of MOU: This MOU will be effective form the date of agreement and will gave an ignition duration of 02 (Two) years. The MOU may be extended will the consent of both the parties.
- 2. Engagement of department level coordinator: The colleges will empower an appropriate faculty to co-ordinate the implementation of activities.
- 3. Confidentiality: Both the colleges will maintain confidentiality about the terms and conditions of the agreement.
- 4. Termination of MOU: the MOU may be terminated at any time with a 30 days prior notice from either party.
- 5. Modification: Any alternation/modification to the MOU may be done with mutual consent of both the parties. Involvement of new departments/activities may be done from time to time with mutual consent of both the colleges.
